Background

It is necessary and desirable for The Illinois State Toll Highway Authority (“Tollway”) to retain certain financial firms to provide, on an as-needed basis, underwriting services in connection with the issuance of new bonds.

Pursuant to competitive procurement process RFP#16-0155, on June 22, 2017, the Tollway approved Resolution No. 21288 authorizing, for an initial term of three years, the Chairman or the Executive Director to assign, as needed for each bond issuance, a bond underwriting group consisting of firms from a Senior Pool and Co-Manager Pool, each as authorized by the same Resolution.

In the past 10 years, actions initiated by FINRA against Piper Sandler & Co. include findings that the firm untimely submitted documents relating to primary offerings to MSRB's EMMA filing system (2016), inaccurately reported a coding indicator and average price disclosure to the RTRS system (2015, 2011), failed to timely report certain TRACE eligible products (2014), inadvertently sold a stock short during a temporarily prohibited period of time (2012), untimely submitted a compliance report filing in the state of Indiana (2012), did not produce a mutual fund transaction letter upon request (2011), and consented to findings that not all electronic mail communications were retained during a period prior to this ten year lookback (2010), each of such actions resulting in fine and/or censure. The SEC ordered a cease and desist against the firm for failings related to the Municipalities Continuing Disclosure Cooperation (MCDC) Initiative (2015) and failings related to a Bond Anticipation Note issue for the City of Wenatchee, WA Regional Center (2013), resulting in monetary fines and censure. Concerning the bidding or sale of municipal investment contracts and municipal derivative products during a broad DOJ investigation across numerous firms including Piper Sandler & Co., several plaintiffs consolidated into a class action suit and Piper Sandler & Co. entered into a settlement agreement for In re Municipal Derivatives Antitrust Litigation in the amount of \$9.8 million in the third quarter of 2015. Additionally, Piper Sandler & Co. received a petition at law in the Iowa District Court from Central College Iowa, who ultimately dismissed the case against Piper after our summary judgment motion was granted in 2015.

Piper Sandler & Co. discloses any material legal proceeding, including regulatory proceedings, on our Form 10-Q and 10-K as filed with the Securities and Exchange Commission and maintains our Form BD filed with FINRA, which contains relevant details regarding any disciplinary actions.
