The work under this contract includes: Removal of the southbound outside shoulder and the southbound & northbound median shoulders and replacement with temporary pavement; construction of two median crossovers; installation of temporary roadway lighting; sewer improvements; maintenance of traffic; and all other work as shown in the plans.
