

RESOLUTION NO. 22525

**Background**

Resolution No. 18516, adopted on November 20, 2008, provides for toll rate adjustments as follows:

Beginning at 12:01 a.m. January 1, 2018, and at the same time and date each year thereafter, commercial rates will be adjusted by the percentage change in the Consumer Price Index for all Urban Consumers (CPI-U), or its successor index, over the 12-month period ending on June 30<sup>th</sup> of the previous year.

Resolution No. 18516 was subsequently affirmed by Resolution No. 19498, adopted on September 29, 2011, and Resolution No. 19480, adopted on August 25, 2011.

Based on the percentage changes in CPI-U, annual toll rate adjustments for commercial vehicles (“CV”) beginning January 1 of each of the years 2018 – 2022 are set forth below.

The percentage change in CPI-U over the 12-month period ended June 30, 2022 would result in an annual CV toll rate adjustment of 7.173% effective January 1, 2023.

To reduce volatility in the annual CV toll rate adjustment from year to year and increase near-term predictability of such adjustments, which will facilitate financial planning and budgeting, it is in the Tollway’s best interests to revise the

annual CV toll rate adjustment methodology. Rather than base the annual CV toll rate adjustment on the percentage change in CPI-U, or its successor index, over a 12-month period, the annual CV toll rate adjustment should be based on the annualized percentage change in the CPI-U, or its successor index, over a 36-month period.

While such change will not materially impact total toll revenues over a timeframe of 3 or more years, such change will reduce the annual CV toll rate adjustment effective January 1, 2023 from 7.173% to 3.650%.

To implement the change in methodology, certain notices, certificates and estimates from an Authorized Officer of the Tollway and the Tollway’s Traffic Engineers and Consulting Engineers are required. See Amended and Restated Trust Indenture of The Illinois State Toll Highway Authority (“Tollway”), Section 713, subsection 4 (“Indenture”).

**Resolution**

Beginning with the annual CV toll rate adjustment effective January 1, 2023, the methodology for calculating the CV toll rate adjustment will be based on the annualized percentage change in the CPI-U, or its successor index, over the 36-month period ending on June 30th of the prior year. On behalf of the Tollway, the Chief Financial Officer is designated the Authorized Officer for the purposes of preparing and filing notices, certificates and estimates required by Section 713, subsection 4 of the Indenture.

**NOTE REGARDING SCRIVENER'S ERROR IN RESOLUTION NO. 22526**

Resolution No. 22526 incorrectly refers to Contract No. 22-0131 as Contract No. 22-0118 and does not refer to "other Tollway contracts." Therefore, the Background Section of Resolution No. 22526, dated September 15, 2022, should have provided, and should be amended to provide as follows:

**Background**

To upgrade its public safety call handling infrastructure, The Illinois State Toll Highway Authority ("Tollway") is procuring CallWorks CallStation Hardware, Software, Installation, and Support Services through the Illinois Department of Innovation & Technology's ("DoIT") master contract with Motorola Solutions, Inc., Tollway Contract No. 22-0131 and other Tollway contracts. The hardware and software needed for the upgrade will cost \$2,474,131.16, and installation services will cost \$557,399.88, for a not to exceed upper limit of compensation on Contract No. 22-0131 and other Tollway contracts of \$3,031,531.04. These goods and services were procured pursuant to 44 Ill. Adm. Code 1.1040.

DoIT currently is working to extend its master contract. The Tollway will purchase the needed hardware, software and related maintenance and support services under DoIT's contract and will purchase installation services only after the anticipated contract extension is secured.
