The improvements to be constructed under this contract shall be performed along the Reagan Memorial Tollway (I-88) from Mile Post 114.2 to Mile Post 114.9 in Kane County Illinois. The work under this contract includes but is not limited to reconstruction of pavement for Ramps A (WB) and B (EB), crack filling on loop Ramps C (EB) and D (WB), widening of approximately 400 feet of Ramp B, toll Plaza parking lot rehabilitation, and other miscellaneous work as shown on the plans.
